

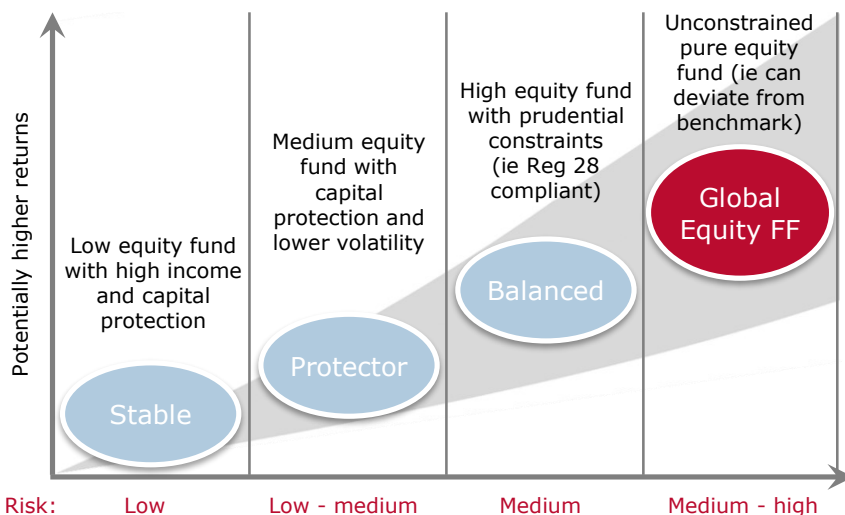

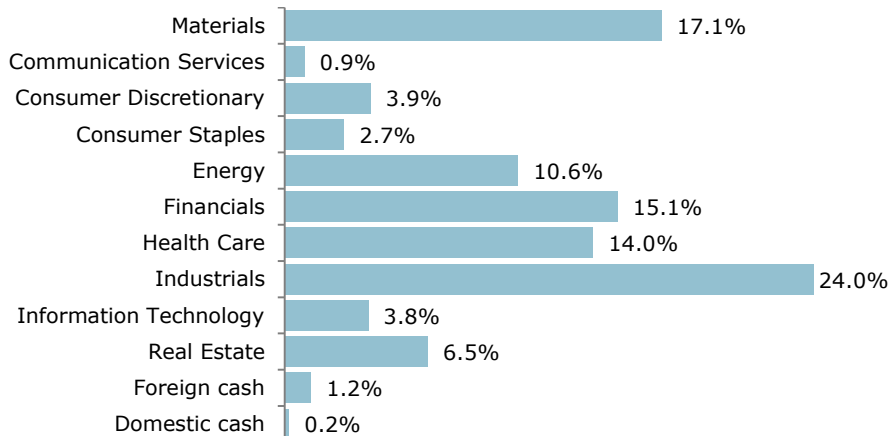


Risk profile

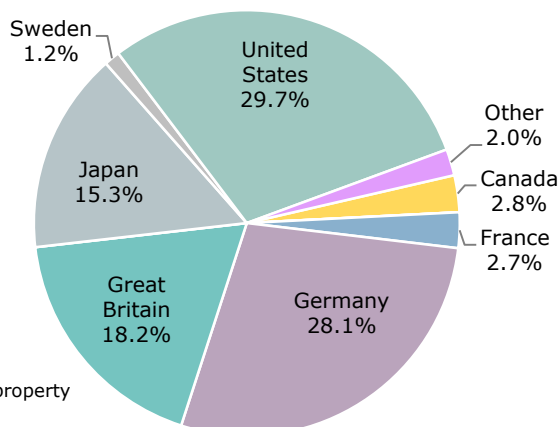

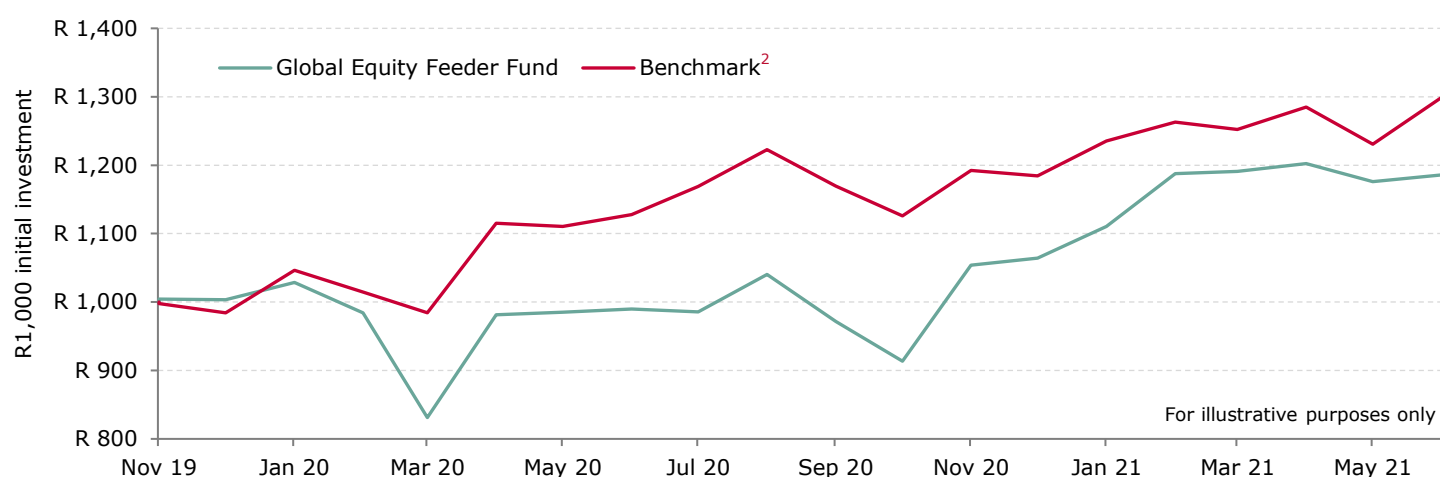
