
# Camissa Islamic Balanced Fund September 2024




## Risk/return profile

The underlying investments will comply with Shariah requirements as prescribed by the Accounting & Auditing Organisation for Islamic Financial Institutions (AAOIFI). The fund will not invest in any interest-bearing instruments.


