

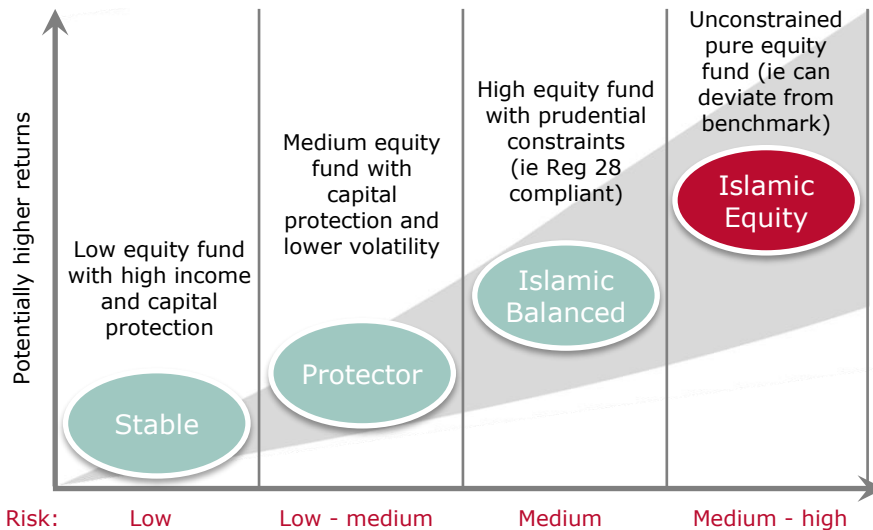

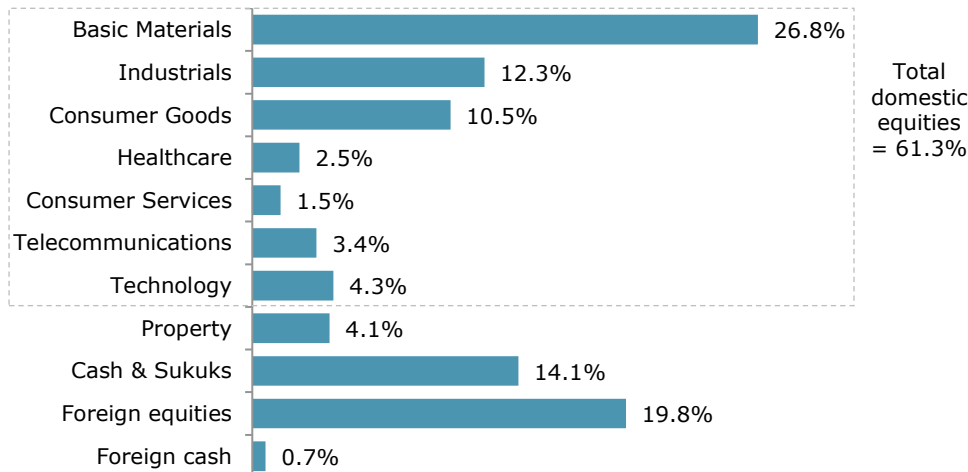


## Risk profile

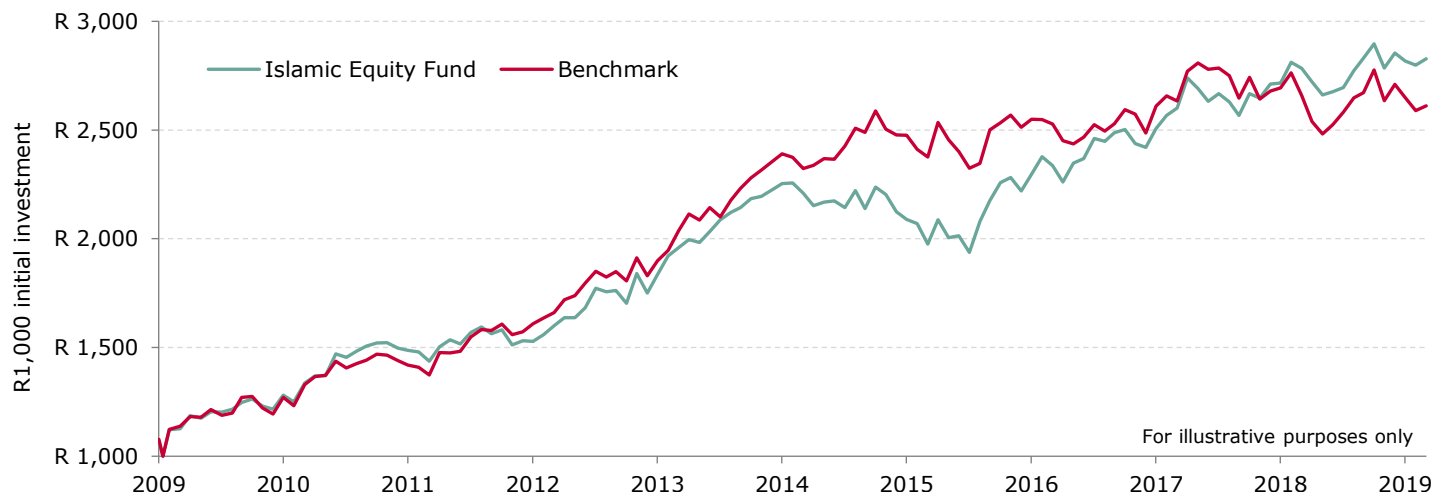
