

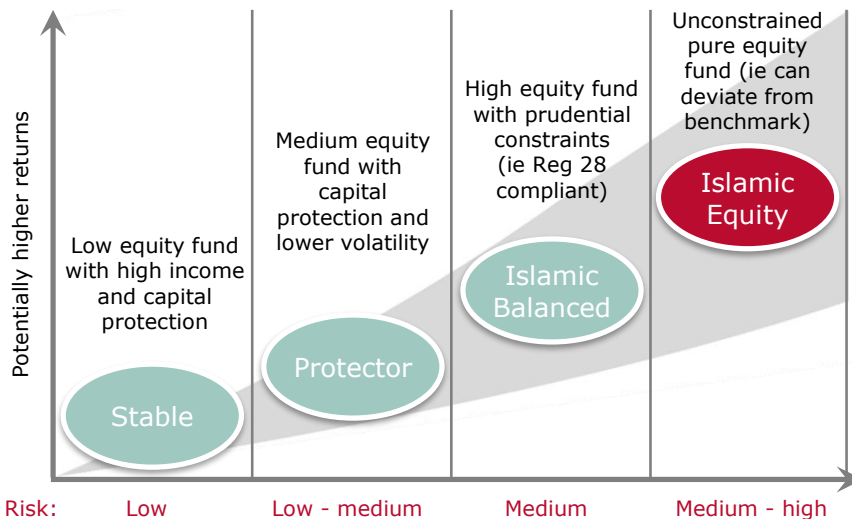

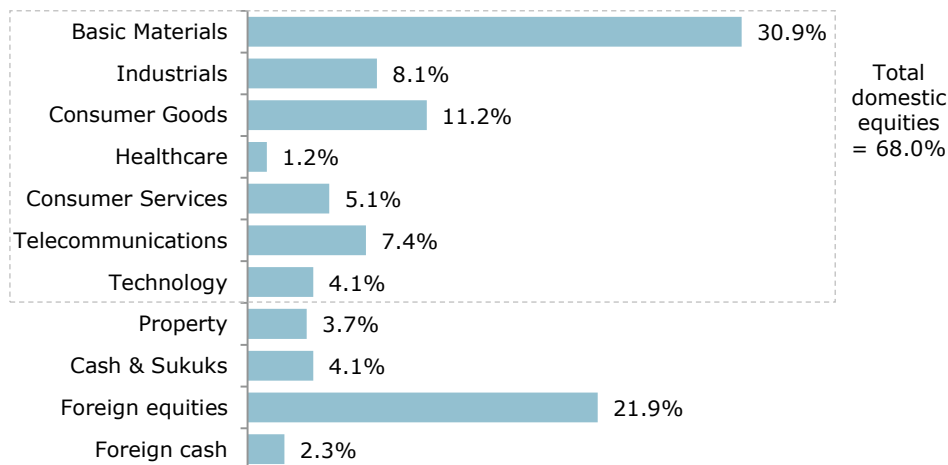


Risk profile

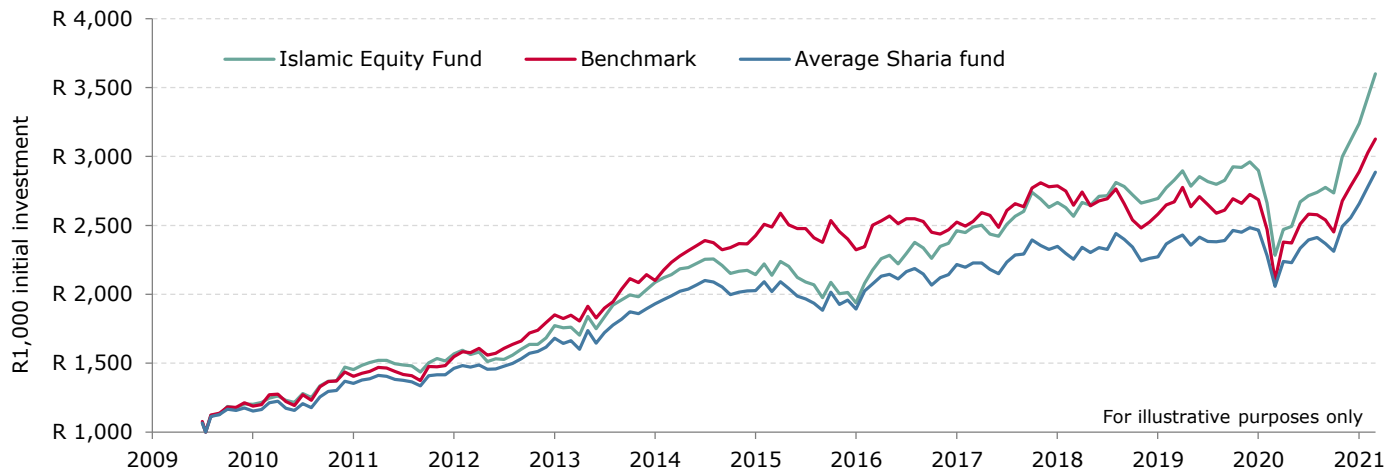
