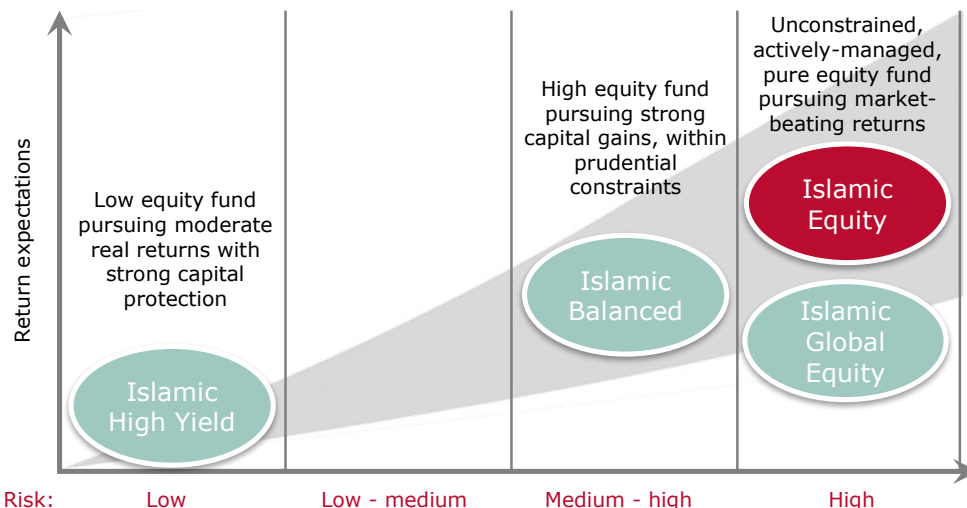

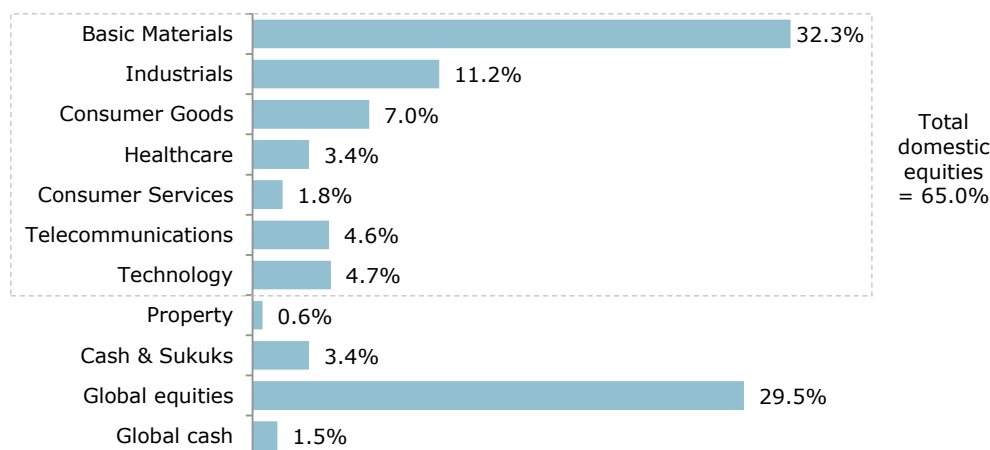

The underlying investments will comply with Shariah requirements as prescribed by the Accounting & Auditing Organisation for Islamic Financial Institutions (AAOIFI) and will not invest in any interest-bearing instruments.

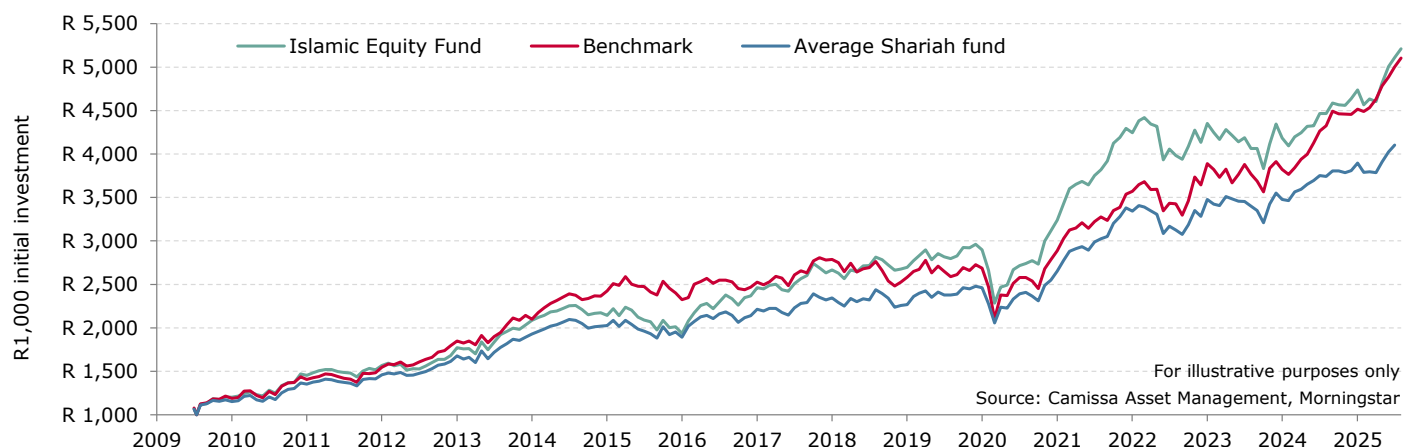

NAV refers to the value of the fund's assets less the value of its liabilities, divided by the number of units in issue.
