

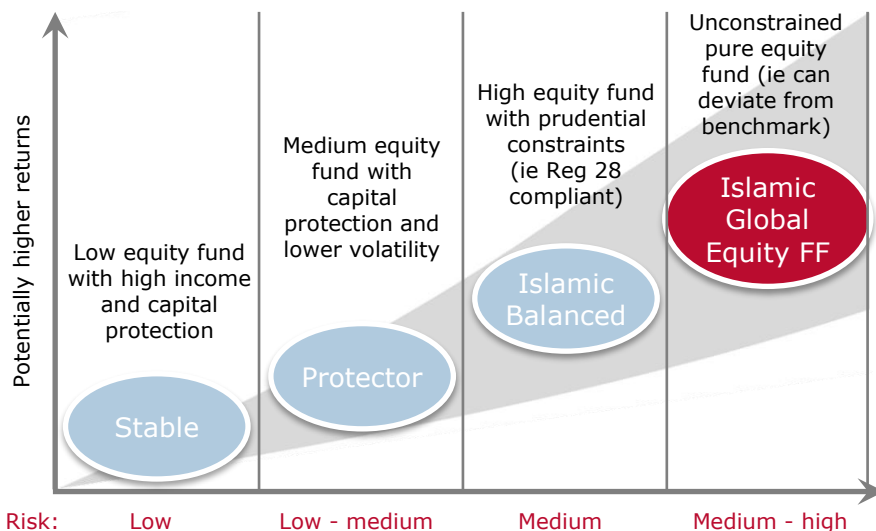

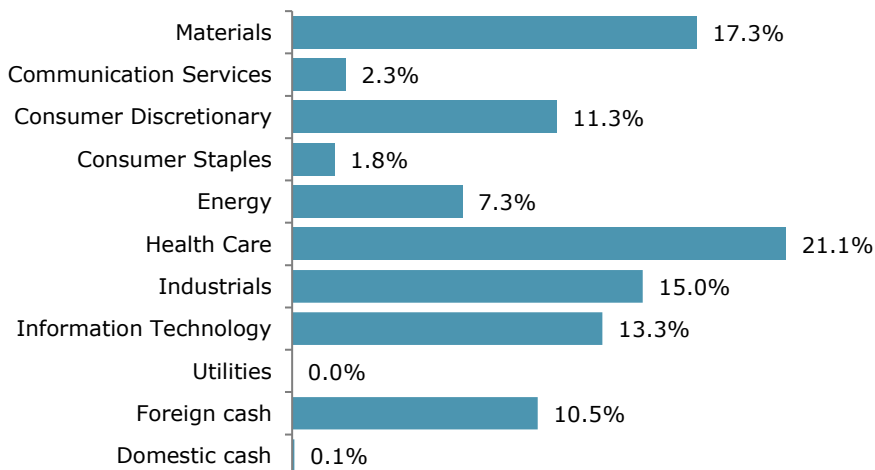

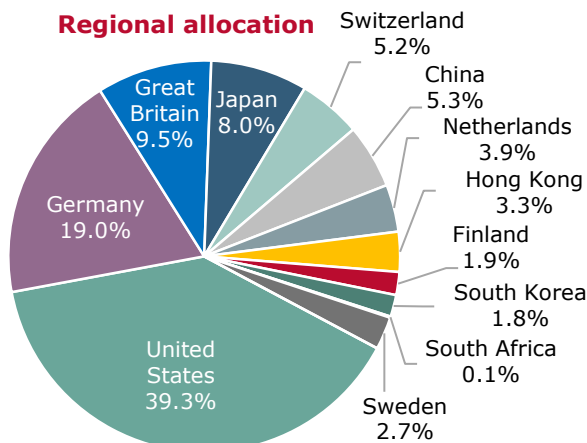
Asset and sector allocation

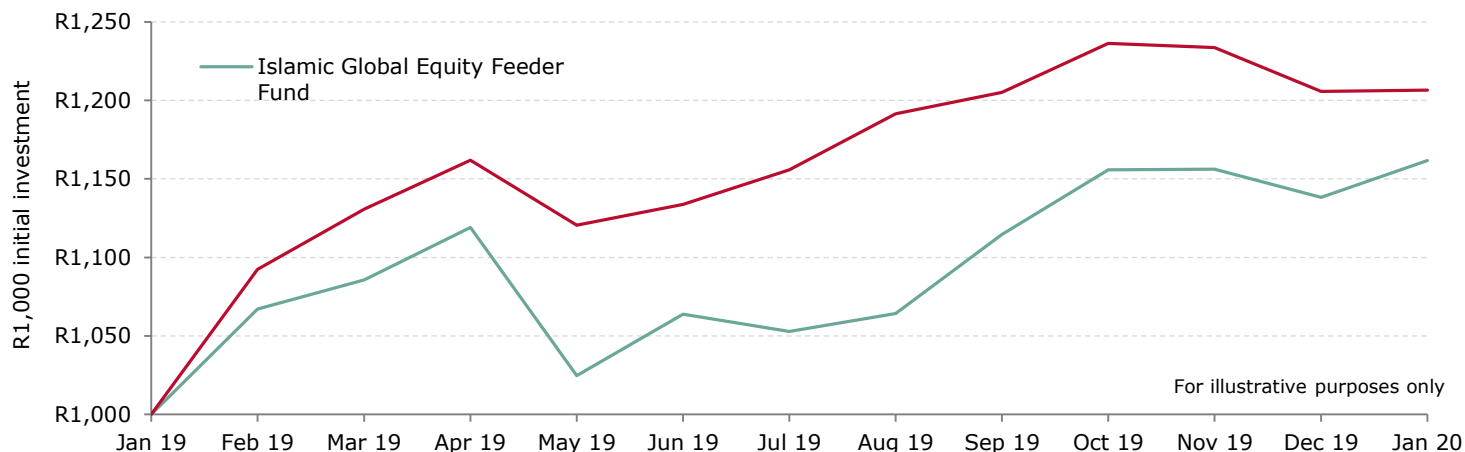
