

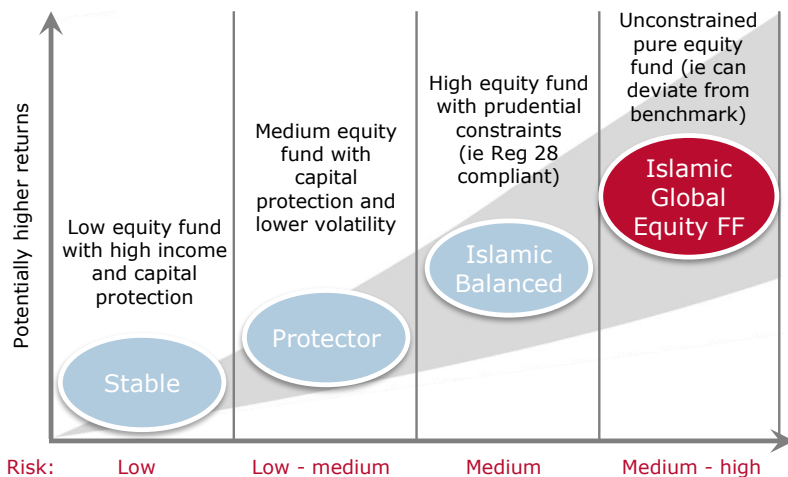

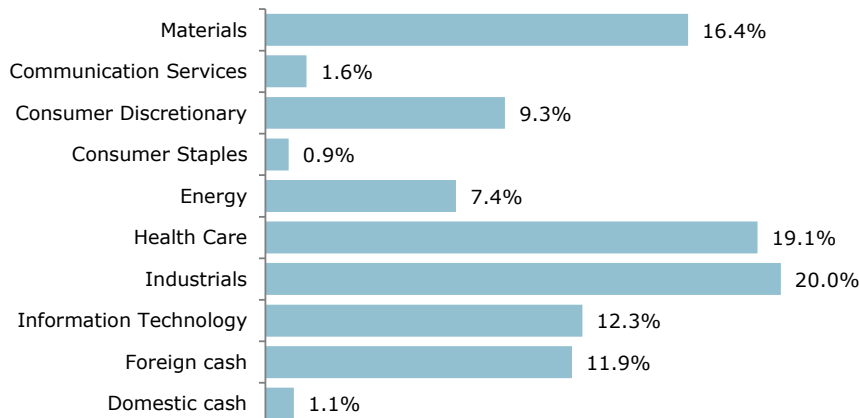


Risk profile

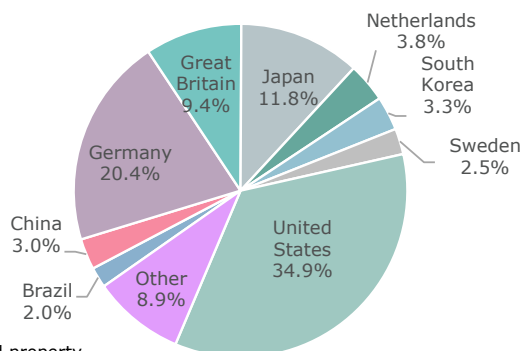
Asset and sector allocation

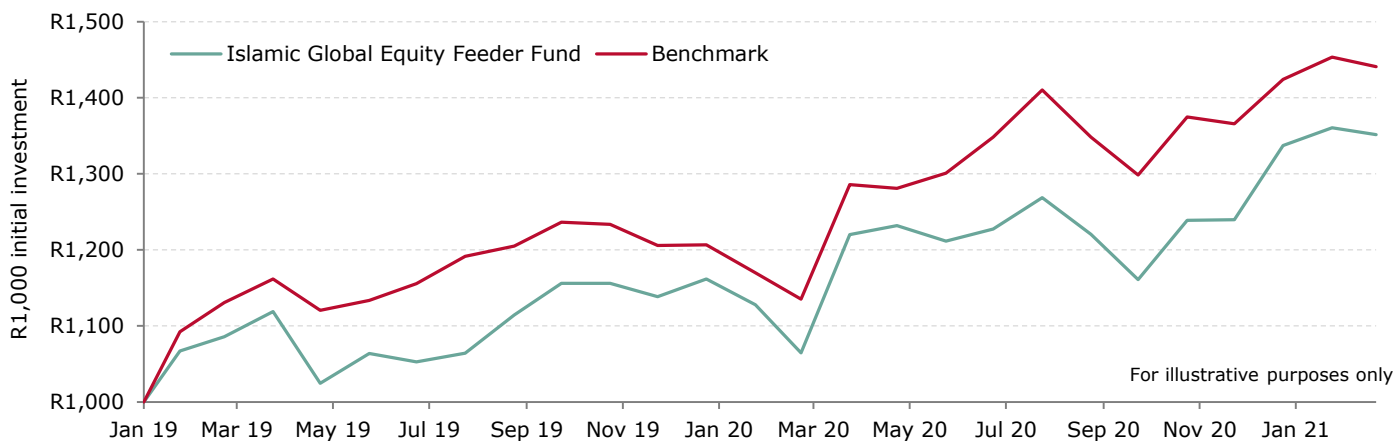
