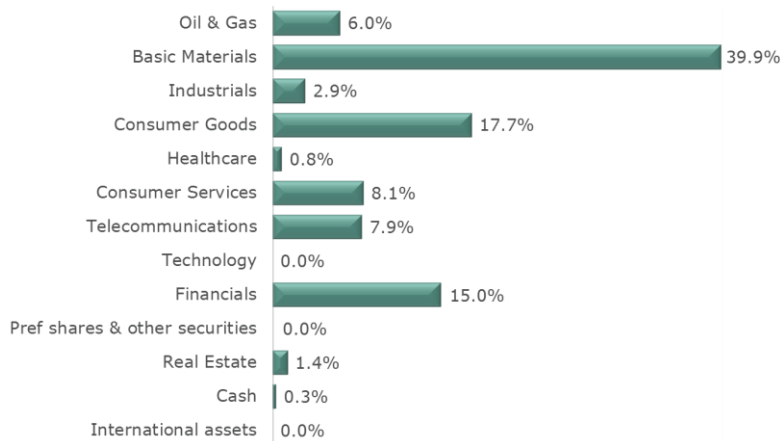
Cumulative performance since inception
