

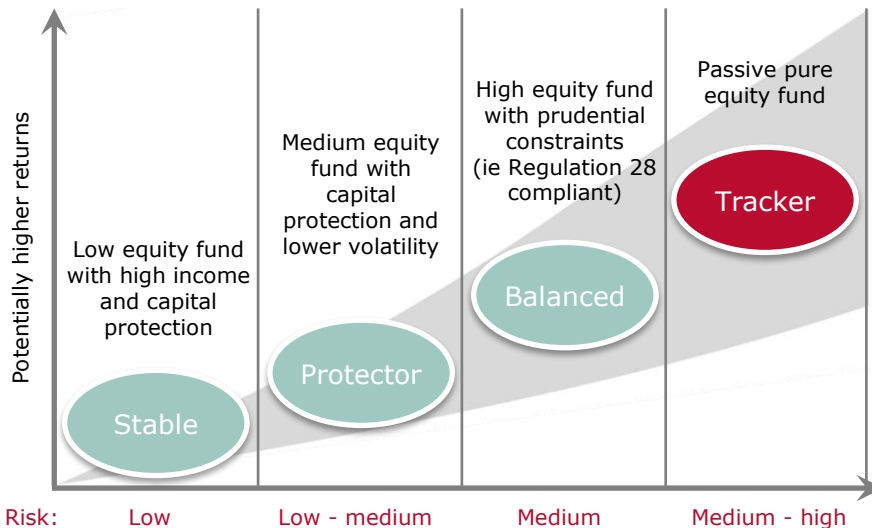

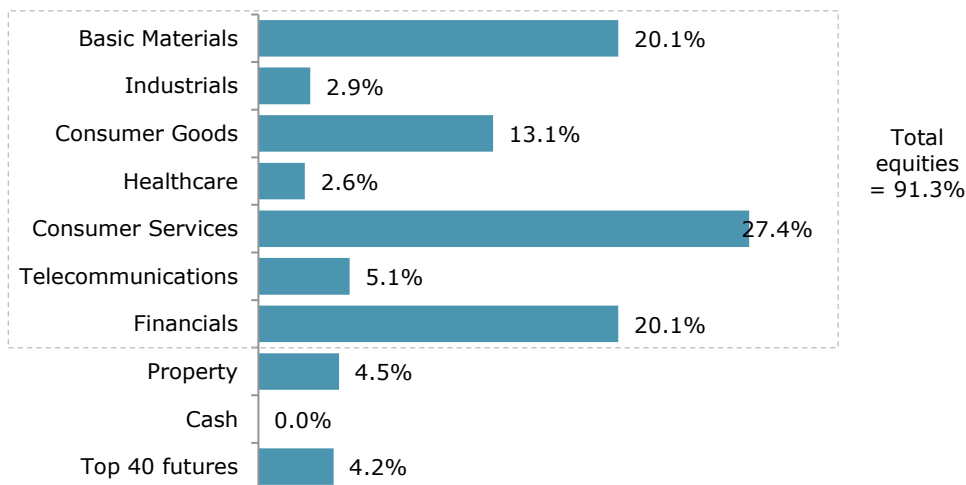


Risk profile

Asset and sector allocation

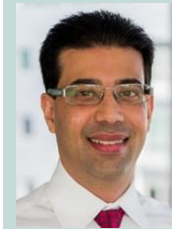

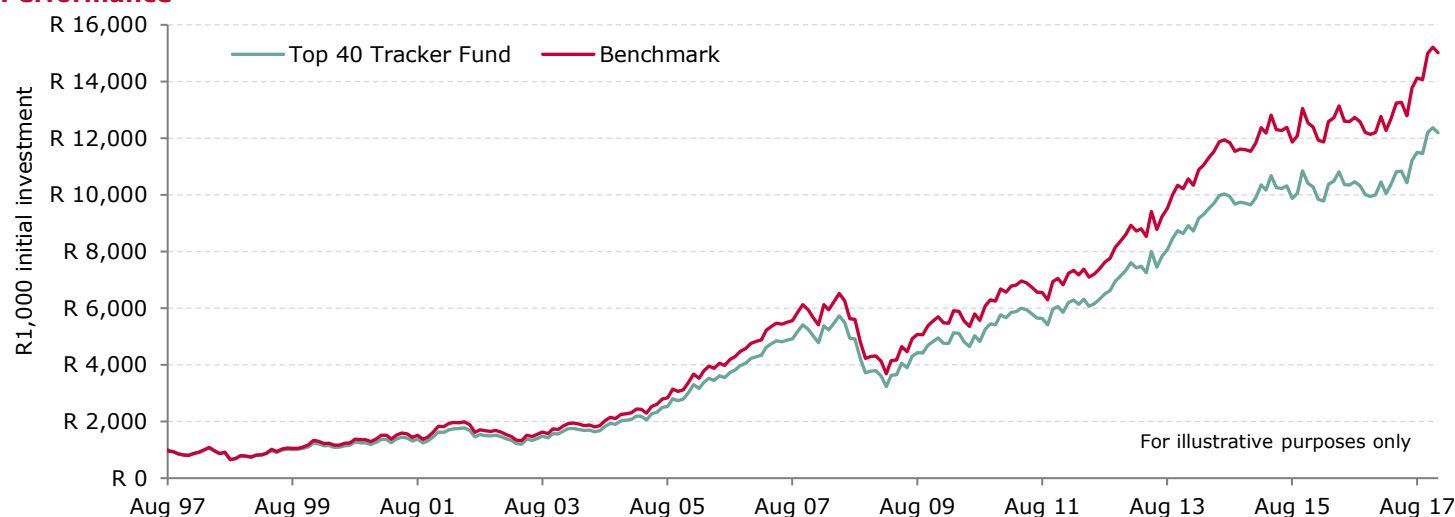

NAV refers to the value of the fund's assets less the value of its liabilities, divided by the number of units in issue.
