

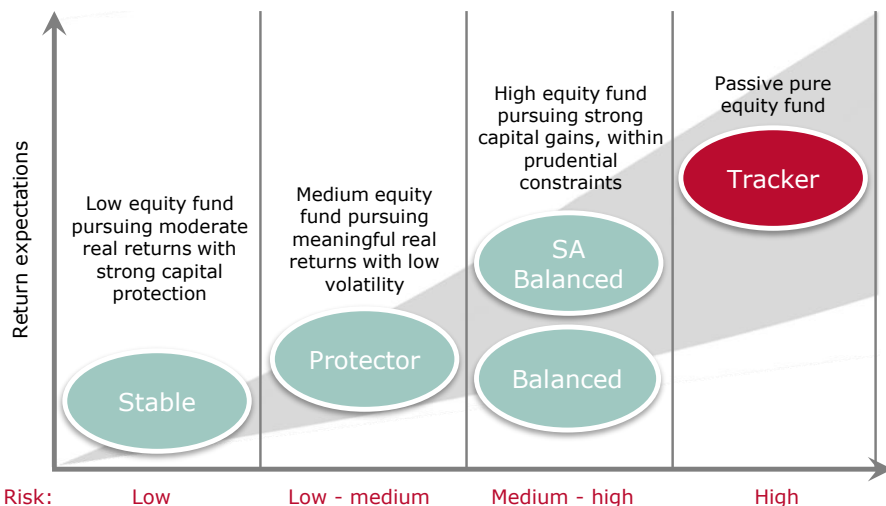

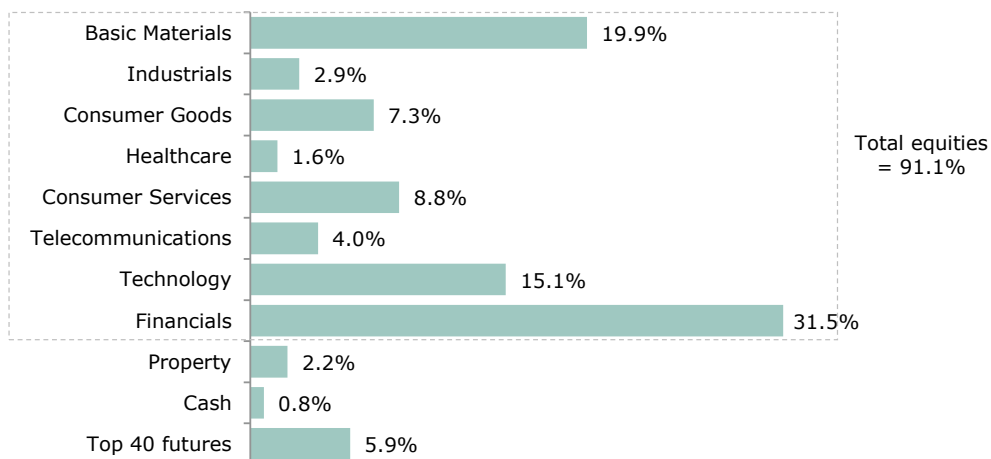


### Risk/return profile

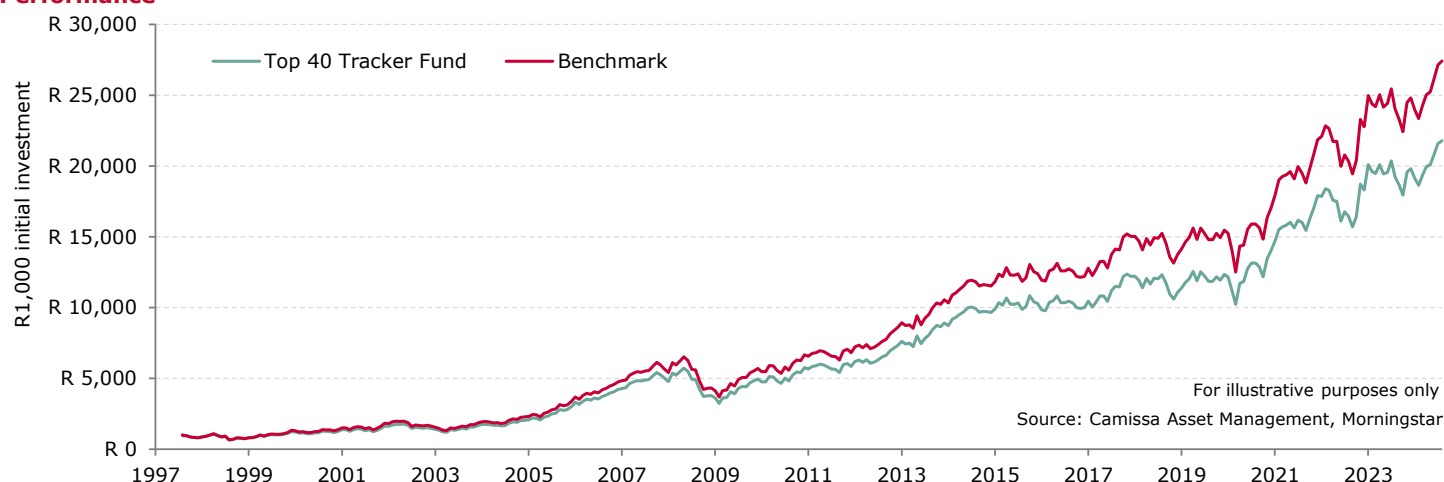
